Packaging, transportation and assembly	
Open the box at the top side, Take out the body of the operating chair, the base and the gas spring. Place the base on the ground and insert the gas spring into the tapered seat. Insert the body of the operating chair into the end of the gas spring. The operating chair is ready to use.

Do not exceed the loads indicated in the section "Technical features". Do not remove the labels attached to the device. Should these become damaged, have them replaced.

CLEANING AND DISINFECTION

To clean and disinfect the external surfaces of the operating chairs (part, painted and upholstered parts), use standard commercially available disinfectants, ensuring that the active substances listed are present in the maximum concentrations indicated.

WARNING!

Do not exceed the concentrations indicated: do not use products containing alcohol, ammonia, abrasive substances or benzol; wipe the disinfected parts with a cloth dampened with water (the disinfectants, even if diluted, can spoil the surfaces).

- Glutaldeyhde 2%:10%
- Ethanol 96%:40%
- Formaldehyde:0,01%
- Glyoxal:0,15%
- Propanol:35%

The products are to be applied using a soft cloth dampened with disinfectants:do not spray the disinfectants directly onto the apparatus in order to avoid seepage into the apparatus, which could affect its performance.

NORMAL MAINTENANCE

The seat does not require special maintenance; periodically clean the wheels so that they slide better.
